NOW THEREFORE THIS AGREEMENT WITNESS AS FOLLOWS:

1. This contract shall be valid for a period of 2 years with effect from 13th of June 2017 initially and same can be renewed or terminated by mutual consent with the 30 days minimum notice from either side.
2. The company agrees to provide all the materials, machineries, tools and articles to the Contractor to do the work as assigned from time to time as required at its premises.
3. The contractor shall arrange for the pickup transportation and disposal of the items mentioned above at their site on contract basis as per mutually agreed terms and conditions of payments.
4. The contractor shall arrange to pick up to material at least once in month or on call basis by the company
5. The contractor agrees to submit the bills of his charge to the concerned facility and company agree to make the payment of the same bill within ten working days of submission of the bills by A/C payee Cheque after the statutory Deductions like TDS applicable from time to time
6. That the contractor will not deploy Child Labour / Young Labour / Forced & Bonded Labour at his premises or at the premise of the company. The company may depute personnel from their team to verify this and at no point should they refuse the entry to them.
7. It is to be ensured by Nagesh Trader that no any misuse will be done of scrap material to be taken from Arihant Flexi Pack.
8. It is to be ensured by Nagesh Trader that waste material taken from Arihant Flexi pack shall not be scrap at any unauthorized places or way.
